Dear Sir / Madam

As you are aware, the Draft Basic Assessment Report in respect of the Proposed Phase 2 Extension of Houmoed Avenue and upgrading of Masiphumelele Informal Settlement was available for public comment some time ago. This notification serves to advise that the application for Environmental Authorisation for this phase of the project has officially been withdrawn prior to submission of the final documentation to the Department of Environmental Affairs and Development Planning (DEA&DP).

A new application will be submitted in due course as allowed for by the EIA Regulations (2014), as amended. A further notice will be circulated guiding Interested and Affected Parties (I&APs) on the opportunity to engage with the new process. Note that all public participation undertaken in terms of the previous application will constitute 'pre-application public participation activities' in support of the new application.

The withdrawal was prompted by a change in the mechanism to secure the wetland offset into perpetuity. The new application will also provide an opportunity for further clarity on the interpretation of EIA process related matters which were raised in terms of the previous process.

A new Draft BAR is being compiled and will be available for review in due course. The new report will highlight the key changes made for ease of reference.


