Notice is hereby given of a combined public participation process in terms of the National Environmental Management Act (Act No. 107 of 1998) (NEMA) and the National Heritage Resources Act (Act No. 25 of 1999) (NHRA). The public participation process for this proposed development and associated Basic Assessment process is being undertaken in accordance with the Public Participation Plan approved by the Department of Environmental Affairs and Development Planning (DEA&DP) on 13 October 2020.

As previously communicated, the proposed development entails the development of a "New Retreat", for the Bertha Foundation which would have the capacity to accommodate up to approximately 34 overnight guests/attendees. Up to approximately 24 parking bays (which includes 7 visitors parking bays) would be included. The site would be accessed from the existing Ou Wa-pad.

The existing building footprints of the remnant cottages on site would be used, where possible. The proposed development would comprise of the following buildings:

- Accommodation buildings to accommodate up to 34 overnight guests/attendees, which include bedrooms, bathrooms, a lounge/communal living area and covered outdoor areas/deck space;
- A conference facility which includes a small conference venue and up to approximately two breakaway areas;
- A communal dining and lounge area;
- An administration building with a reception and waiting lounge / library;
- Meeting room(s) for community programmes and a communal library; and
- A kitchen area, with space for staff dining, lockers, and ablution facilities.

The proposed additions and alterations would expand upon the existing built footprint and there would also be a large landscaping component with a combination of hard- and soft-landscaping interventions, which also includes a relatively large fynbos rehabilitation component.

Note that since the distribution of the pre-application Draft Basic Assessment Report (from 6 November to 10 December 2020), scope has been added to the proposal. This includes a temporary water pipeline which would be constructed within an existing road/road reserve to connect to an existing

private irrigation supply line to provide potable water to the site until a permanent pipeline is constructed. The proposed permanent pipeline would connect to municipal supply in Lanquedoc and be located within roadway or within transformed areas next to the road. A Maintenance Management Plan (MMP) for a watercourse at the site has furthermore been compiled and included in the Environmental Management Programme (EMPr) for the development.

The proposed development triggers the following Listed Activities in terms of the Environmental Impact Assessment Regulations, 2014 (as amended in 2017):

The proposed development furthermore triggers Section 38 (1) (c) of the NHRA (Act No. 25 of 1999). In terms of the National Water Act (Act No. 36 of 1998), the Department of Water & Sanitation (DWS) has confirmed that the Section 21 (c) and (i) water-uses triggered by the development can be Generally Authorised.

The Basic Assessment process is now in the post-application phase (i.e. the application for Environmental Authorisation has been submitted to the DEA&DP) and engagement with various I&APs is continuing. The post-application Draft BAR and associated specialist studies, including the updated Heritage Impact Assessment (HIA) will be available for public review and comment for the duration of the comment period described below. All comments received during the previous public review period have been incorporated into the Draft BAR and associated appendices (where relevant) and the responses have also been recorded therein.

This letter serves to advise you that the post-application Draft BAR and associated specialist assessments (including the updated HIA) are available for a **30-day public review period** from **23 November 2021** to **13 January 2022.**
